Introduction:

The following information is a summary or synopsis of the documents released by the CIA as a result of the Freedom Of Information Act (FOIA) request made in 2017 by John Greenwald Jr. Mr. Greenwald is a writer, Blogger and, Host of “the Black Vault” podcast.

The MUFONCT committee has been reading through the CIA documents and where possible summarizing down to basic information. This is not an attempt to interpret or judge the content provided by the Agency but is an attempt to provide useful information to inform the reader.
